The PAU Department wishes to appoint three (3) Early Stage Researchers to conduct fundamental research on the potential of a new tool for renovating degraded public space and improving the attractiveness and accessibility of deprived urban areas by focusing on the high potential local commercial activities. The exploration is oriented to the implementation of an innovative tools: CLUDs, Commercial Local Urban Districts, aimed at emphasizing the strategic role of small retail-handcraft and typical food- in reinforcing the sense of community reducing transportation costs and contributing to the creation on attractive urban environment, thus producing increase of private investment.

The Early Experienced Researcher will join a Marie Curie IRSES project, entitled Commercial Local Urban Districts' Programme (CLUDs) The coordinator of the network is the Mediterranean University of Reggio Calabria Italy – Department PAU.

The research will be conducted in the Mediterranean University of Reggio Calabria Italy – PAU Department, with opportunities for collaborative work with the European partners composed by the FOCUS Center University of Rome “La Sapienza”, the University of Salford, the University of

Uppsala and with the opportunity to conduct part of the research at the US universities – Northaestern University of Boston (MA) and San Diego State University (CA).

The candidates are expected to have knowledge and in the use of relevant urban management tools and a familiarity with the urban regeneration practice and knowledge of “Centri Commerciali Naturali in Italy”.

Fluency in oral and written English is required, and a suitable qualification will be required by the PAU Department .

In accordance with Marie Curie terms, applicants can check their eligibility for this "Early Stage Researcher" Fellowship position in the attached document "Annex III – Specific Provisions Marie Curie International Research Staff Exchange Scheme” .

Benefits of this Marie Curie contract include the amount of 2100 Euros per month spent in US host organizations.

The duration of this Marie Curie contract is 8 months until the first reporting period of the entire research. The duration can be extended to other 4 months during the second reporting period of the entire research.

The Coordinator of the CLUDs project reserves the right to terminate the collaboration with the selected candidates in case of the quality of work produced or the entire work produced by him/her does not respect the request fixed in the document of work and/or does not contribute to the achievement of the planned results.
